Sparklers Are Dangerous

Every year, young children can be found along parade routes and at festivals with sparklers in hand, but sparklers are a lot more dangerous than most people think.

Sparklers burn at about 2,000 degrees – hot enough to melt some metals. Sparklers can

quickly ignite clothing, and children have received severe burns from dropping sparklers on their feet. According to the National Fire Protection Association, sparklers alone account for more than 25% of emergency room visits for fireworks injuries. For children under 5 years of age, sparklers accounted for nearly half of the total estimated injuries.

Consider using safer alternatives, such as glow sticks, confetti poppers or colored streamers.

Ice Cream Sandwich Cake

24 vanilla ice cream sandwiches, unwrapped

2 (80z) containers of whipped topping 1 (120z) jar hot fudge ice cream topping, warmed

1 (12oz) jar caramel ice cream topping ¼ cup chopped, peanuts, Snickers, Butterfinger, sprinkles or any ice cream favorite topping.

Arrange a layer of ice cream sandwiches in the bottom of a 9X13-inch dish, cut them to fit evenly. Spread a layer of hot fudge then caramel and lastly whipped topping. Repeat layering starting with ice cream sandwiches and ending with a top layer of whipped topping. Sprinkle with chopped peanuts or your favorite topping.
